General

This Agreement (as amended from time to time and together with any applicable Ride2Work Purchase Order, "this Agreement") defines the terms and conditions of the Evans Cycles Ride2Work Programme it will govern the way that business is conducted in relation to the Ride2Work Scheme

between _____ of _____ (known from this point forward as "The Company") and F.W. Evans Cycles (UK) Ltd, Company No.2784079, whose registered office is at Camino Park, James Watt Way, Crawley, West Sussex, RH10 9TZ ("Evans Cycles").

The Ride2Work Scheme (the "Ride2Work Scheme") is a scheme operated by Evans Cycles in connection with the Department For Transport Cycle to Work Scheme to assist The Company in leasing bicycles and related accessories ("Bicycle & Equipment") to employees of The Company (each "an employee").

Advice given by agents or servants of Evans Cycles during telephone/Internet orders from employees is based entirely upon information given. Where advice is given after visual inspection by agents or servants of Evans Cycles, such advice shall amount to an opinion only and Evans Cycles shall not accept liability for any inaccuracies.

Notwithstanding any other provisions of this Agreement, nothing in this Agreement shall confer, nor is it intended to confer, a benefit on any third party (for the purposes of the Contract (Rights of Third Parties) Act 1999 or for any other purpose).

Evans Cycles promises to offer the same service levels to The Company and the employee as it would to other customers. Notwithstanding that the product is being purchased by The Company and not the employee, Evans Cycles will offer a free service on each bicycle purchased via the Ride2Work Scheme within six weeks of the bicycle's collection or delivery.

We are committed to protecting The Company's and the employee's privacy. We will only use the information that we collect about you lawfully in accordance with the Data Protection Act 1998. We will collect any information given at the time of the ordering process only to enable us to input and process your order.

Ride2Work Scheme Operation

Upon receipt of a completed Ride2Work Purchase Order from The Company, Evans Cycles shall send a voucher (a "Ride2Work" voucher) for the requested amount directly to the employee stated in the Ride2Work Purchase Order at the employee's address specified on the Ride2Work Purchase Order. By submitting a Ride2Work Purchase Order The Company confirms that they have in place the required contracts between themselves and their employees.

The employee is responsible for (i) collecting the Bicycle and Equipment from an Evans Cycle store by taking the Ride2Work voucher to an Evans Cycles store or (ii) arranging delivery of the Bicycle and Equipment to the employee's home address or to The Company's address by Evans Cycles by contacting the Evans Cycles mail order sales team on 01293 572 325 to arrange delivery. The employee will be required to provide proof of address and signature. The Ride2Work voucher cannot be transferred to another person, or exchanged for cash.

The employee must redeem the full value of the Ride2Work voucher; part redemption or credit against the value of the Ride2Work voucher is not permitted.

Accounting

Evans Cycles will perform a credit check on The Company. Depending on the result of this check The Company may be offered a credit facility or a pro-forma account. Settlement terms for credit accounts are strictly 28 days after delivery of an invoice. Failure to adhere to Evans Cycles' credit terms may result in suspension of issue of Ride2Work vouchers to The Company. Ride2Work vouchers will not be issued for orders exceeding The Company's available credit.

Quotations are given on the assumption that no variation in the price will be made by the manufacturer/sole importer and that Government levies remain unaltered. In the event of such changes, orders placed before the variation will remain the price quoted.

Liability

Evans Cycles will ensure that supplied bicycles and accessories meet all relevant UK and EU standards, and that they are fit for their intended use. Evans Cycles will not be held liable for the failure of goods or personal loss suffered as a result of the following: where the goods have been used improperly; modified or in any way altered from the manufacturers specification (unless by a qualified member of Evans Cycles); where the goods have not been used in accordance with the instruction and advice provided in product documentation or where regular inspection and maintenance requirements have not been met. Parts modified or adapted shall no longer be warranted by the manufacturer nor shall Evans Cycles be liable for death or personal injury to the extent resulting from any such modification. Maintenance should only be performed by an authorised person. Where modifications or alterations and poor maintenance to goods have been made, Evans Cycles shall accept no liability unless caused directly by its own negligence. Nothing in this Agreement is intended to exclude liability which may not be excluded by applicable law.

Where goods supplied to The Company are alleged to be defective, The Company agrees to return such goods to Evans Cycles for inspection and report (without Evans Cycles replacing the said goods prior to such inspection). The Company further confirms that it

shall be reasonable for Evans Cycles to inspect, repair or replace (at its option) such defective goods and allow manufacturers to undertake inspections so as to allow production methods to be modified. Evans Cycles accepts no liability in respect of failure to

supply or other interruptions caused by matters beyond the reasonable control of Evans Cycles, including strikes, lockouts, civil disputes, acts of God, war or actions by third parties.

Delivery

All times given for despatch or delivery are approximate and Evans Cycles shall not be held liable for any loss incurred as a result of delayed delivery. The Company is required to notify Evans Cycles, in writing, of any shortage, mis-delivery or other discrepancy within five days of The Company becoming aware of such failure.

Termination

This Agreement may be terminated by either party on giving to the other not less than 30 days' prior written notice. Any termination will not affect any accrued rights and obligations arising prior to termination.

Amendments and Notices

This Agreement may only be amended in writing and signed by both parties. All notices shall be in writing and unless, notified otherwise by a party, shall be sent by mail to the address set out on the first page of this Agreement.

Governing Law and Jurisdiction

This Agreement shall be interpreted in accordance with English Law and English courts shall have exclusive jurisdiction in respect of any dispute arising there from. In respect only of Internet sales, this Agreement shall be deemed to be made in Crawley, West Sussex, irrespective of any rule of contract dictating otherwise.
